7.How much the shipping cost ?

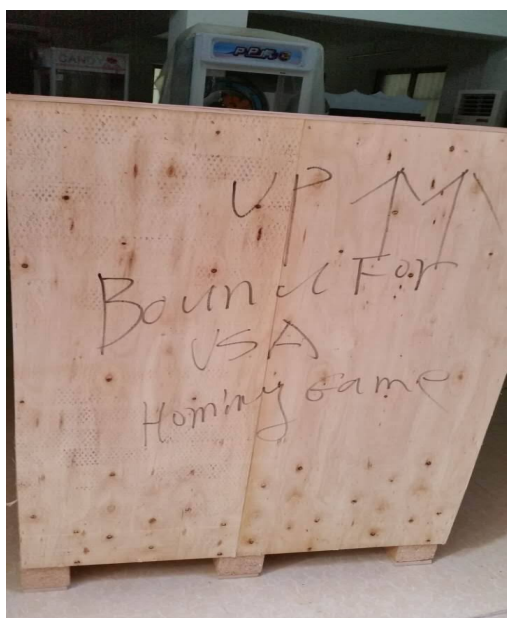

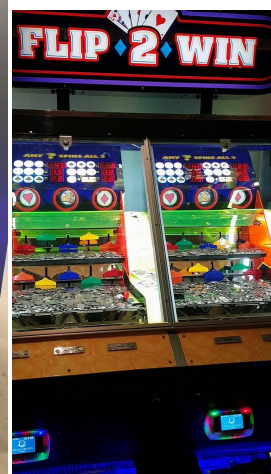
